Sec. 28-111. Definitions.

The following words, terms and phrases, when used in this article, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

City means the city, its employees and authorized agents.

Person means any legal entity, including an individual person, partnership, corporation or association, except the city, its employees and its duly authorized agents.

Street or alley means the entire width between boundary lines of every public right-of-way, whether, open to vehicular traffic or not.

Street bank means the accumulation of snow and ice along the outside edges of the open portion of a street which results from the snow plowing operations of the city.

Sec. 28-112. Plowing of snow and ice regulated.

No person shall take or remove, or cause to be removed any snow and ice from any private property or premises and place, dump, pile or leave such snow and ice within any street or alley, except as provided herein.

Sec. 28-113. Procedure for plowing snow into streets.

Any person may remove snow and ice from a driveway or sidewalk which is 12 feet or less in width and pile said snow and ice in a street, provided that:

(1) Said snow and ice shall be placed only along, parallel with and as a part of the street bank;

(2) Said snow and ice shall be placed so that no part of it extends further into the open portion of the street than the existing street bank;

(3) Said snow and ice shall be placed only on that portion of the street bank which is adjacent to the property from which said snow and ice was removed, and no closer than 25 feet from any street intersection;

(4) Said snow and ice cannot reasonably be accumulated and be kept elsewhere on the private property or premises where said driveway or sidewalk is located.

Sec. 28-114. Removal of street bank in front of driveways.

No person shall take or remove or cause to be removed any snow and ice from any street bank and place, pile, dump or leave said snow and ice within any street or alley, except in the same manner as provided in section 28-113 for removal of snow from private property.

Sec. 28-115. Removal of improper snow piles.

The city may move or remove any snow and ice which has been moved, piled, dumped or placed in violation of this article, and charge the cost of such removal to the person found in violation of this article.

Sec. 28-116. Civil liability.

Any person who places, moves, or removes snow and ice in any street or alley as provided in this article does so upon the condition that said person shall save and hold harmless and indemnify the city from any liability resulting therefrom.

Sec. 28-117. Penalty.

Any person violating any of the provisions of this article shall be guilty of a municipal civil infraction.
